### **Bordeaux Village Association No. 1, Inc.**

#### FREQUENTLY ASKED QUESTIONS - UNIT OWNERS

#### Q: WHAT ARE MY VOTING RIGHTS?

**A:** You are afforded full voting rights on all matters requiring a vote or those issues on which the Board of Directors desires a consensus. Your vote is equal to that of any other unit owner on all such matters. Each Unit is entitled to cast one 1) vote.

#### Q: WHAT RESTRICTIONS EXIST ON MY RIGHT TO USE MY UNIT?

**A:** Restrictions are presented in the following places: Declaration of Condominium, Article 22, Obligations of Members; the By-Laws, Article 10, House Rules, and supplemental Rules and Regulations promulgated by the Association's Board of Directors.

#### Q: WHAT RESTRICTIONS EXIST ON THE LEASING OF MY UNIT?

**A:** Pursuant to the Associations Documents and Rules and Regulations, a completed Application to Lease form is required, along with an application administrative fee of \$150.00 non-refundable (\$100 application and \$50 processing fees) per prospective adult resident. A \$350 security deposit made payable to the Association to protect against damage to the common elements and/or the Association property will also be collected and held in an escrow account. A minimum lease term of at least one (1) year is required. Units are not eligible to rent out for one (1) year after purchase. Intention to rent out a unit must be submitted in writing to the Board for approval as there is a 20% cap on unit rental.

## Q: HOW MUCH ARE MY ASSESSMENTS TO THE CONDOMINIUM ASSOCIATION AND WHEN ARE THEY DUE?

**A:** The monthly Association dues are due on the first day of each month and are considered late if not paid by the 15th. A late fee is assessed if the dues are received after the 15th of the month. The Association's dues during 2024 are \$599.00 per month.

#### Q: DO I HAVE TO BE A MEMBER IN ANY OTHER ASSOCIATIONS?

**A:** No. You are not required to be a member of any other Association.

### Q: AM I REQUIRED TO PAY RENT OR LAND USE FEES FOR RECREATIONAL OR OTHER COMMONLY USED FACILITIES?

A: No. You are not required to pay rent or land use fees for recreational or other commonly used facilities.

# Q: IS THE CONDOMINIUM ASSOCIATION INVOLVED IN ANY COURT CASES IN WHICH IT MAY FACE LIABILITY IN EXCESS OF \$100,000?

A: No. The association is not involved in any such court cases.
